## TOOMBS COUNTY LONG RANGE TRANSPORTATION PLAN



The Georgia Department of Transportation (GDOT) has recently partnered with Toombs County to develop a multimodal Long-Range Transportation Plan (LRTP). Its purpose is to determine the County's current and future transportation needs through the year 2045, and identify projects that address community needs and promote economic vitality and quality of life.

Much of Toombs County is comprised of land that is characterized as rural, with low population and employment. Understanding this, the study will especially focus on smaller-scale roadway improvements, such as passing lanes, intersection improvements, and paving projects, as well as multimodal improvements (may include rail, freight, bicycle and pedestrian, and public transportation) that will serve community mobility into the future.

The study's success relies on the involvement and input of local residents, community leaders, and businesses and employees.
